Chairman Harris called the meeting to order and welcomed everyone in attendance.

Minutes:

The **November** meeting minutes were presented to the board and **approved** as presented. The motion **was made** by Bill Davies, seconded by David Renz. The **motion passed unanimously.**

Financials:

Budget Amendment #2:

2024 Budget:

The **2024 Budget** was presented to the board by Carl Campbell. Mr. Campbell explained that Murray Count support was added, grants are now broken out, and we are maintaining 30K in residential funding. The 2024 budget was **approved** as presented. A **motion was made** by Bill Davies, seconded by Bob Caperton. The **motion passed unanimously.**

Rural Workforce Housing Initiative Housing Construction Loan Program:

Carl Campbell explained that Mr. Fernando Paniagua has expressed interest in participating in DCA's loan program. This program requires approval for the JDA to be a conduit for the construction loan for Fernando's home construction for phase II at the Coahulla Creek Subdivision. This is dependent upon him qualifying through DCA for the loan, and providing the needed documentation to protect the JDA from default.

A **motion was made** to appoint Bill Davies, Robert Smalley, and Carl Campbell to an advisory committee to review the request. The board will approve based on the group's opinion and authorize the authority to sign documentation based on the approval. The **motion was made** by David Jolly, seconded by David Renz. The **motion passed unanimously.**

Directors Report:
